MEMORANDUM OF ASSOCIATION

- A.** The name of the foundation is **NAGAR ALO FOUNDATION**
- B.** The registered Office of the foundation shall be situated at **House No 18 (4th Floor), Road No 2, Block E, Mirpur, Pallabi, Dhaka-1216**, Bangladesh.
- i) Area of Operation:** The area of operation of the foundation shall be extended all over Bangladesh.
- ii) Nature of the foundation :** It is a non-profitable, non-political, non Governmental, Charitable and voluntary foundation.
- C. Objective and purpose:** This Foundation is a non-profitable, non-political and charitable organization. It will perform its activities, to the best of its efforts, in the interest of the mass people regardless of race, religion, color and gender. All the objects will be implemented after obtaining necessary permission from the Government/ Concerned authority/ Competent authority before implementation of the objects and the objects contrary of the provision of Section 20 of the Act shall be treated as ineffective.
- To carry on humanitarian or charitable program among the poor people.
 - To publish rare/old manuscript of the lost folklore of the country including the myth book after being collected them.
 - To take initiative for distribution of relief among the neglected poor people.
 - To train the illiterate and half-literate people for increasing their performances by ensuring advanced education system.
 - To aware the common people, poor people and human society for their humanitarian activities.
 - To set up library or reading room for growing reading habit to the common people.
 - To publish rare/old manuscript of the lost folklore of the country including the myth book after being collected them.
 - To arrange exhibition of sculptured /collection of painting through display center, museum and mobile museum.
 - To set up museum for display of sculpture and painting.
 - To set up institute of fine Arts for arrangement of drawing competition.
 - To publicity about literary works among the common people.
 - To arrange publicity regarding archeological and historical monument and to establish educational research centre.
 - To collect and preserve machinery and scientific equipment and to aware to the people for its usefulness.

14. To establish Mosque and Madrasa for enhancing the quality of Islamic education and to distribute free books amongst the poor Alema and Olama.

Income:

The income and property of the Foundation what so ever derived shall be applied salary towards the promotion of the objective and the purposes of the Foundation as set forth in this Memorandum of association and no portion thereof shall be paid or transferred directly or indirectly to the members of the Foundation or otherwise providing the nothing herein contained shall prevent the payment in good faith remuneration, salaries, gratuities, honorariums, and allowances to any servant of the Foundation or to any staff of the Foundation thereof person in return for service actually rendered to the Foundation.

Fund:

In order to be able to fulfill the objectives of the foundation, the foundation will:

- a). Accept donation in cash or in kinds from any person, institute, foundation, NGO'S or Companies and from home or abroad use the same toward the promotion and maintenance of the objectives of the foundation and create, provide funds to apply the same as the foundation any deem expedient for the fulfillment of its objectives, provided that the foundation shall not receive any foreign donation without undergoing the formalities as laid down in the foreign donation (voluntary activities) regulations ordinance (ordinance no. XXXI of 1982) as amended from time to time
- b). Pay out the funds of the foundation or out of any particular part of such funds all expenses incidentals to the formation and managements of the foundation or of administering any special trust or otherwise carrying out any for the forgoing objects including the payments for the salaries to persons employed in this foundation.

Dissolution Or Winding up:

If upon the Winding up or dissolution the foundation, there will remain any assets after Liquidation all its debts and Liberties, will not be paid to or distributed among the members of the Foundation, but will be give or transferred to or applied to some other societies, to be determined by the 3/5th Majority of the Foundation.

THE SOCIETIES REGISTRATION ACT, 1860
(ACT. XXI OF 1860)
RULES & REGULATIONS
OF
NAGAR ALO FOUNDATION

1. In these rules and regulations, unless the context otherwise requires:-
- a). The Foundation means "**NAGAR ALO FOUNDATION**"
 - b). President means President of the Executive Committee.
 - c). Office means the registered office for the time being of the foundation.
 - d). Government means Government of the People's Republic of Bangladesh.
 - e). Members means a member of the foundation whose name appears and/or is borne on the Register of the Members.
 - f). Month means English calendar month.
 - g). Seal means the common seal of the foundation.
 - h). General meeting means a General Meeting of the foundation.
 - i). Ordinary Meeting and Extra-ordinary meeting mean respectively an Ordinary General Meeting and Extra-ordinary General Meeting.
 - j). Rules means any rules, regulations, by-laws and procedures framed by the Executive committee for the proper function of the foundation.
 - k). Proxy means an attorney duly constituted or appointed under an instrument of proxy, power of attorney or other authority in writing.
 - l). In writing and written include printing, lithography, laser printing, type writing, telex, fax, e-mail and other modes of representing or reproducing words in visible form.

Membership:-

2. There are **4 (Four)** types of members of the foundation. The classes of this member are as follows:

- a. Founder Member**
- b. Life Member**
- c. General Member**
- d. Donor Member**

General Member:-

3. Any citizen of Bangladesh or other country of any religion, cast and creed will be able to be a member of the foundation if he/she:
1. Agreed to abide by the Memorandum of Association and constitution of the Organization and intend to devote himself/herself for the welfare service.
 2. If the organization approves his/her application in the specific form of the organization.
 3. If agreed to pay admission and monthly subscription as fixed by the Executive committee from time to time.
 4. Person/ organization willing to implement aims and objectives of the organization can be member of the organization.

Founder Member:-

4. First Executive body will be the founder member of the foundation.

Life Member:-

5. Any person who will donate Tk. 50,000 (taka fifty thousand) as subscription to the foundation. She/he will be the life member of the foundation. She/he will be selected by the Executive committee of the foundation. They have no voting right. Report will be provided them.

Donor member:-

6. Executive Committee may select any person to be Donor member along with any type of donation with specific amount of money to be decided by the EC. They have no voting power in this foundation.

7. **Cancellation of Membership:-**

Membership shall be cancelled or suspended for the following reasons.


- i. Without attending in three consecutive meeting showing no reasons.
- ii. Working against of the organization.
- iii. If the person expired or become mad or accused by the court.
- iv. Being involved with the subversive activities the state.
- v. Being defaulter of monthly subscription for continuing six months.
- vi. These provisions will not be applicable for the founder Members.

Reinstate of Membership:-

8. The person's whose membership is cancelled or suspended apply to the President within 30 days and with the recommendation of any EC member stating the reasons in a paper. Membership can be reinstated if EC approve it.

Organizational Structure:-

9. The Foundation shall have the following bodies.
- i. The General Body.

- ii. The Executive Committee.
- iii. The Advisory Committee.

The General Body:-


10. There shall be a General body of the Foundation and it shall be composed of all members of the foundation. The President of the foundation will preside over meeting of the general body. The general body will approve plans, policies and strategies for the foundation. It will elect the EC among members after five years. The general body will also approve yearly budgeted, financial statement and appoint the chief Executive officer and other top level Executives. The general body will hold meeting at least forth times in year one of which will be the annual general meeting.

The Executive Committee:-

11. The Executive committee will be elected for a period of five years. The sitting EC will take appropriate organization steps to hold the EC election at the end of each term. The composition of the Executive committee shall be as follows:-

a. The President of the Foundation	(1) person
b. The Vice-President of the Foundation	(1) person
c. The General Secretary of the Foundation	(1) person
d. The Assistant Secretary of the Foundation	(1) person
e. The Finance Secretary of the Foundation	(1) person
f. The Organizing Secretary of the Foundation	(1) person
g. The Office Secretary of the Foundation	(1) person
h. The Executive Member of the Foundation	(2) persons
	(9) Persons

- A. President-** He/she will be the constitutional head of the foundation. He/she will preside over all the meeting. He/she will give cooperation to all members and officers for proper implementation of various projects of the foundation. He will collect and preserve all necessary papers documents of the foundation. He will write administrative letters regarding funds. Letters with other organization. Communicate the same manage contract with all concerns. He will contract, negotiate and consult with everybody for overall development of the foundation. He will perform necessary contract. Execute documents, collect fund, prepare project and will coordinate in implementation of the foundation. He will run activities of the foundation. He will be able appointed officers and staffs and dismiss members, officers and staffs, which are necessary for the foundation. All decision will be decided and approved by the President.
- b. General Secretary:** He will supervise all administrative and day to day works. He will call all types of meeting discussing with the President and will prepare the meeting. He will run all activates of the foundation. He will run administration, project preparation, budget preparation, program implementation and evolution. He will arrange the writing of minutes of all meetings. In absence of President he will organize all activities of the foundation. He will co-operate the organization of the project work of the organization keeping cooperation with everybody. All this will be done period to approval of the executive committee.
- c. Finance Secretary:** He will maintain all monetary accounts and prepare budget of the organization in consultation and under instruction of the President and General Secretary. He will preserve all accounts, documents in written and will organize audit works.

- d. **Executive member:** Will perform responsibilities as may be entrusted to them by the executive committee. Will undertake all task for the interest of the foundation. They will give overall assistance to the executive committee.

Advisory Committee:

12. There shall be an advisory committee not less than 05 (five) persons be nominated by the executive committee. It shall render advice on any matter referred to if by the executive committee and annual general meeting. The executive committee will try to make good use of the advisory committee.

Meeting of Executive Committee:

13. In persons of 2/3 (two-three) members of the executive committee at any such meeting shall form a quorum and each member has one vote.

The executive committee shall not meet less than forth times a year.

The foundation shall keep at its office a register containing that names and address and occupations and nationality of the members of the executive committee and shall send to the register of any changes that may take place in the names address, occupations or nationality such members of the executive committee.

Any one member of the executive committee may request a special meeting thereof to be called by the general secretary by giving seven days notice of his/her desire to the general secretary, in case of emergency or urgent reference by giving three days notice to the general secretary but at such special meetings no business other than specified in the notice shall be taken into consideration, save by the unanimous consent of those present.

Emergency meeting may be convened with specific agenda with 24 hours notice in the event of emergency.

Minutes of all proceeding of the committee shall be made and regularly entered into a minute book to be kept by the general meeting and copies circulated among members, the book shall be open to the inspection of any member at any responsible time.


Any casual vacancy against any member of the executive committee, arising from death, resignation, removable or otherwise may be filed by com-opted shall hold office for the unexpected portion of the member causing the vacancy.

The executive committee shall undertake not withstanding any vacancy therein and not withstanding any defect in its construction and no act or proceeding of the executive committee shall be invalid by season only of the existence of any vacancy among its or any defect in its constitution.

Annual General Meeting:-

14. It shall be at least once in a calendar year. Fourteen days notice shall be given to every members before holding general meeting starting the time and place of such meeting and the business to be transected in such meeting 2/3 members will from the quorum for the annual general meeting.

15. Membership fees, regular subscriptions, donations received from members of the foundation, well-wishers, business communities, and governmental national and international organizations will constitute the funds for the Foundation.

Earning through training programs, research projects, consultancy will also contribute to the fund of the foundation. Grants, loans from any local Bank or financial institutions will be treated as the fund.

Bank Account opening and operation

16. All Bank accounts will be opened in any schedule bank under joint signature of the President, General Secretary and Finance Secretary. In any critical situation, EC members may take decision regarding bank account opening. To operate area office account, nature of signatories & style will be decided by the Executive Committee. For bank operation and withdrawal of money finance secretary must be the signatory. Any one from other two will be signatory. But for above TK-50000/- written approval must be taken from the president

Seal:

17. The executive committee will provide a security common seal for the foundation if necessary. The seal will be deposited with the President.

Audit:-

18. The executive committee will get the accounts of the foundation audited by any Chartered Accountants (CA) firm or by social welfare. Audited report will be submitted and approved in the annual general meeting.

Amendment:

19. Executive committee, if necessary will be able to propose/recommended alternation, extension, addition and limitation of any section, sub-section or work of the constitution. The same will have to be approved in 3/5 percent legal members of total legal members in next annual general meeting of the foundation.

Dissolution of Foundation:-

20. If upon winding up or dissolution of the foundation there remain, after the satisfaction after debts and liabilities, any properties whatsoever, the same will be handed over or given to some other institutions having objectives similar to the objectives of the foundation, to be determined by the 3/5 percent voting of the member of the foundation in the extra ordinary general meeting at or before the Desolation.
